Thank you for your interest in this ground-breaking CPD-accredited training on spiritual abuse — a widespread, under-recognised safeguarding issue affecting children, vulnerable adults, and entire communities. The training is a live, interactive session (delivered online or inperson by request) and includes case studies, real-world examples, and actionable strategies.

While faith-based coercion has become increasingly visible in media reports and safeguarding cases, spiritual abuse remains a blind spot in many safeguarding policies, training programmes, and risk assessments. This training is here to change that.

Rooted in lived experience, shaped by survivor leadership, and grounded in safeguarding best practice, this course will equip professionals to recognise and respond to signs of spiritual, cultic, and coercive religious harm — especially when it's hidden in plain sight. This training can also be adapted for attendees working within religious or faith-based settings, with an emphasis on spiritually safe leadership, safeguarding-conscious pastoral care and trauma-informed, abuse-aware ministry practise.

Why This Training Matters

Spiritual abuse is not legally defined, often falling between the cracks of existing safeguarding frameworks. It includes manipulation, control, exploitation, and psychological abuse — all under the guise of faith or doctrine. It disproportionately affects young people, Black and minoritised communities, and women. Many survivors are not believed, and frontline professionals may feel ill-equipped to intervene. This course fills that gap — so survivors don't have to fall through it.

Why This Training Matters in Faith Spaces

Some religious communities may carry unique vulnerabilities in their group culture or structures- such as rigid hierarchies, unchallenged authorities or blurred boundaries between pastoral care and control. When left unexamined, these dynamics can create environments where coercive coercion and abuse are not only possible, but normalised. This training equips faith leaders and pastoral teams to recognise these risk factors, take accountability and build spiritually safe spaces rooted in integrity, safety and transparency.

This course is designed and delivered by **Rachael Reign DipHE (Law)**, an internationally recognised survivor advocate and expert on cultic and spiritual abuse- specialising in this kind of abuse within black and brown communities.

- ✓ Understand the psychological and safeguarding impacts of spiritual abuse.
- ✓ Respond safely and appropriately to disclosures.
- ✓ Recognise legal and professional frameworks for intervention.
- ✓ Support victims and survivors and challenge harmful spiritual narratives.
